HOUSING RULES AND REGULATIONS CONTRACT
2017-2018

The Student and Parent/Legal Guardian acknowledge that the following rules and regulations are in full force and effect for the housing premises. The rules are to promote the convenience, safety, peace and welfare of the students residing in the premise. The Student acknowledges that these rules are sufficiently explicit in the prohibition, direction, or limitation of the Student's conduct to fairly inform the Student of required conduct and Student acknowledges notice of these rules when entering into the housing contract. This acknowledgement is indicated by Student's signature below. Those Students found in violation of these rules and regulations are subject to dismissal from the housing area and program by Believe Sports Academy.

1. No person shall be in the housing area while under the influence of alcoholic beverages, cereal malt beverages or illegal drugs. There shall be no consumption, storage or sale of alcoholic beverages, cereal malt beverages or illegal drugs in the housing area.
2. There will be absolutely NO SMOKING allowed in any of the housing area. Failure to abide by this rule will result in disciplinary action.
3. There shall be no pets housed in or around the housing area.
4. The sidewalk entries, passages, and stairways of the housing area shall not be obstructed or used for any other purpose than for entering and exiting the housing area.
5. No Student shall interfere in any manner with any portion of the heating and lighting apparatus in or about the housing area.
6. No additional locks shall be placed upon any door of the building without written consent of a Believe Prep Academy staff member.
7. Students shall not play musical equipment or instruments at such hours and at such volume as to disturb others in the housing area.
8. Students agree that the cleanliness of the housing area is important. Believe Sports Academy and staff have the right to inspect for cleanliness and in the event a room is found unsatisfactory, the Students will be given notice to clean until satisfactory.
9. Any damage to the rooms and/or housing area will be assessed to all members of that specific room or housing area unless responsibility can be established to the contrary. The cost of repairs will be due and owing upon completion of the repairs. Students are not allowed to do repair work in the housing area.
10. Any tampering with fire extinguishers and smoke alarms will result in disciplinary action and the cost of replacement equipment will be billed to the students.
11. There will be no flammable materials or explosives stored in or about the housing area. This includes petroleum products, fireworks, etc.
12. There will be no firearms or weapons (including paint-ball guns) permitted in the housing area.
13. Parents/Legal Guardians are responsible for all personal belongings of the student. This includes clothing, jewelry, bedding, electronic equipment, etc. Believe Sports Academy is not responsible or liable for items left behind at the housing area when the student leaves. Believe Sports Academy is not liable for lost, stolen, or damaged property of the student.
14. There shall be no disorderly conduct (i.e. no fighting, destroying property, etc.).
15. Students shall not take or use the property of another student without consent.
16. **No over-night guests are permitted. No person under the age of 18, not accompanied by parent(s), shall be in any housing unit, or in the parking lot adjacent to the housing units, without first obtaining permission from the Housing Supervisor, his/her designee, or another Administrator of Believe Sports Academy.**

Failure to abide by the above rules and regulations will result in disciplinary action. I acknowledge that I have read these Rules and Regulations and agree to abide by them. I also understand that I am financially responsible for any damages caused to my designated room, housing area, or facility/campus while attending Believe Sports Academy.
